# 2024-2025 BUDGET

Discussion ensued with Justin Downes, Highway Supervisor regarding staffing levels. The Board decided to fund one additional full-time Public Works position.

A motion was made by Ms. Davis, seconded by Mr. Barry to approve line 1046 for \$30,000. All in favor.

A motion was made by Ms. Davis, seconded by Mr. Fredsall to approve line 1088 for \$695,114. All in favor.

A motion was made by Mr. Casella, seconded by Mr. Barry to approve line 1094 for \$176,329. All in favor.
