- ARPA Mr. Criss shared the draft list of the proposed ARPA project list. Discussion ensued.

- Field Usage Mr. Criss and Burlington First Selectman, Doug Thompson met and agreed to open the fields up in each town for the other town to use without rental charge for a year. Discussion ensued.

- MIRA The Town of Harwinton is given the option to opt out of the contract with MIRA. Mr. Criss shared that by opting out it prevents the town the financial obligation to increasing fees. Discussion ensued. Mr. Brunetti made a motion to opt out of the MIRA contract renewal and to contract with USA. Mr. Honig abstained. Mr. Criss seconded. All in favor; Motion carries.
