Minutes of the Previous Meetings

Appointments and Resignations –

- Mr. Criss shared that the resignation of Dave Bousquet included the resignation of the ADA
 Coordinator. Mr. Criss would like to appoint the new Public Works Director, Justin Downes, to be the
 new ADA Coordinator. Mr. Brunetti made a motion to approve Justin Downes, the Public Works
 Director, to be the new ADA Coordinator. Mr. Honig seconded. All in favor; Motion carries.
- Mr. Criss shared three (3) nominations from Diane Honig for the Board of Selectman's consideration:

 - 2. Economic Development Commission, Weld Royal
 - 3. Inland Wetlands & Watercourses Commission, Marc Matsil

 Request for Tax Refunds – No refunds at this time. Mr. Criss shared two (2) Tax Collector Correction letters with the Board. Mr. Brunetti made a motion to accept and sign the letters. Mr. Honig seconded. All in favor: Motion carries.

First Selectman's Report -

- The Veterans War Memorial The project is up and running. The old monument was moved to the town hall green by the gazebo. The flagpole was moved and donated to the Harwinton Historical Society for the old school house.
- **Neglected Cemeteries Grant** A contractor has been hired to clean up North Cemetery and East Cemetery.
- **Bridges on Valley Road** Mr. Criss shared that they are finalizing the bid documents for the two (2) bridges on Valley Road. Roads are closed to one (1) lane while working is in progress.
- Bogue Road Bridge Mr. Criss shared that Bogue Road Bridge is completed and is now open.
- **EV Station Station** Mr. Criss has been receiving calls about the inactive EV station. He is working with the Recycling Coordinator to utilize grant money to activate it due to the fact that it was not funded by the Board of Finance.
- Security Cameras Are ready to be installed.
- Façade Improvement The contract was reviewed and signed. It will start in October.
- Flag Drop Box A Flag Drop Box was purchased to place next to the Town Drop Box near the main entrance of Town Hall.
- Public Works Director Justin Downes is the new Public Works Director and he will be attending the next BOS meeting. A new Maintainer, Colby Cables, has started as well.

Correspondence – Mr. Criss shared the Tax Collector's report. A letter was submitted Byrne & Byrne LLC announcing the new municipal hourly rate.
