### Director's report:

- Motion by Leslie to purchase a book in Naomi's name, cost not to exceed \$30; unanimous.
- The next town meeting is scheduled for 5-18. Board members who were not officially appointed last year must be present at the meeting to go through the formal process.
- The dehumidifier in the basement is now connected but is not emptying as it should. It is being worked on.
- New computers: There has been an anonymous donation of 2 computers and one PC has been purchased by the town.
- The generator grant has been declined by the Board of Finance and the Selectmen have said it must go through a formal bidding process.
- The library is eligible for a \$15653 grant through the American Rescue Plan Act.
- The reopening is going smoothly. There has been no resistance to wearing masks.
- The Sustainable Shelves program is working out fine.
- Discussion on Acorn TV, which is ending its streaming services to libraries. An alternative recommendation is Hoopla.
   Motion by Leslie to commit \$1500 to Hoopla for a 6-month trial period; unanimous.
- For the Plant, Book and Bake Sale the town has directed that social distancing rules are to be followed. We are to ask that patrons who refuse to follow them leave.
- For the Plant, Book and Bake sale wagons are still needed.
