Commissioner members review the current Investigation Report they are using and believe it could be tweaked a little to achieve the required ZEO information they are looking for. D. Prigitano offered to work on the form and send it to LUC Redmond for distribution to Commissioners. Commissioners are looking for IWZEO David Perkins' input/comments on the reporting forms.

Copies of the Habitat are received and distributed.


