# 1. Open Meeting-establish quorum

Chairman Gil Roberts opens the meeting at 7:02 p.m with members Gil Roberts, Jim Clavette and Glenn McGrane being seating and a quorum is established. Each member sets their name for the record; Janelle Nadeau WPCA Clerk is also present. Proceedings are being audio recorded.

## 2. Ray Drew answers questions regarding the plant upgrade.

- a. Estimated to be 2 ½ -3 yr construction period, with final plan approval in January2017
- b. Estimated costs of upgrade is approx. \$69.9 million, not \$51.3 million as previously estimated.
- c. Ray reviewed construction project and modifications that had to be made that increased overall cost.
- d. Upgrade must be completed by 2020.
- e. Harwinton's portion of the construction costs after grants will be about \$37,000/year for the 20 year bond period.
- f. Under the current state bonding policy three separate bonds will be issued for costs associated with each year's construction. The first payment will consist of two annual payments.
- g. If Harwinton should elect to pay the entire bond off the cost savings will be approximately \$120,000.
- h. The plant upgrade will bring an increase in annual operation and maintenance expenses of approximately \$5000
