2. MARIE FARKAS – APPLICATION FOR AN 3 FOOT EAST SIDE YARD VARIANCE AND A 1% LOT COVERAGE VARIANCE FROM SECTION 5 ZONING REGULATIONS, DATED 10/29/18, FOR CONSTRUCTION OF A 9' X 12' ADDITION TO EXISTING HOME, 23 SILANO DRIVE (TR ZONE).

Dennis McMorrow, P.E., Berkshire Engineering, is present to represent along with Marie Farkas. Plans by Berkshire Engineering titled Zoning Location Survey, dated 1/6/2020 are reviewed. Receipts of certified mailings to neighbors within 200 feet of the property are collected from Mr. McMorrow.

Mr. McMorrow refers to the site plans explaining that the house is already exceeding lot coverage and not meeting building setbacks due to the lot being a grand-fathered legal non-conforming lot containing 0.44 acres. The house is 17.5 feet to the east and does not meet the 25 foot side yard setback. With the addition onto the back of the house, the distance will be 22.3 feet to the east side yard. The property is served by sewer and well and TAHD approval dated 2/5/2020 has been received.
