Richard Girolimon of Richie's Automotive, LLC - application to locate motor vehicle repair business (CT DMV General Repairer's license) in space formerly used by Iffland's Colonial Service Station, (land owned by GRJH Inc of Millerton, NY), Retail Service Zone, 207 Birge Park Road. Discussion/possible decision – Richard Girolimon of Richie's Automotive, LLC - application to locate motor vehicle repair business (CT DMV General Repairer's license) in space formerly used by Iffland's Colonial Service Station, (land owned by GRJH Inc of Millerton, NY), Retail Service Zone, 207 Birge Park Road.

Members discuss, with mention that Iffland's was in the same location for years, that this is the same type of business in a business area, a continued use. There would be no change in the type of business.

Motion Mr. Gelormino, second Mrs. Duchaine to grant approval for the location of the motor vehicle repair business as it is a use already established. The motion passes unanimously.
