1. OPEN MEETING - ESTABLISH QUORUM.

Acting Chairwoman C. Kasey called the meeting to order at 7:00 p.m. All regular members present are seated with Alternate Member N. Schnyer seated for M. Rewenko.

2. APPROVE MINUTES OF PREVIOUS MEETING:

10/9/18 (2 sets; one with motions only, one that is full minutes) and minutes of 10/22/18 meeting.

M. Szydlo **motioned** to approve the minutes of 10/9/18 (both sets) as published, seconded by D. Kovall.

Motion passed unanimously. M. Szydlo **motioned** to approve the minutes of 10/22/18 with amendment to Item 1. to read: All regular members present are seated with Alternate Member Theodore Root seated for *Cynthia Kasey* (omit Nancy Schyner). D. Kovall seconded the motion and it passed unanimously with C. Kasey and N. Schnyer refraining from vote due to their absence at the 10/22/18 meeting.

- 4. DISCUSSION/POSSIBLE DECISION BUMPER BROOK ESTATES, LLC PETITION FOR A ZONE CHANGE FROM LIGHT INDUSTRIAL TO A TOWN RESIDENTIAL ZONE, TWENTY-FOUR BUMPER ROAD, ASSESSORS MAP NOS. A8-03-0003, A8-03-0004 AND A8-03-0006. (Public Hearing closed 9/24/18. 65th day to make a decision without extensions: 11/27/18.) LUC Redmond has forwarded emails to Commissioners from Town Attorney Michael Rybak regarding a WPCA agreement with Bumper Brook Estates. Atty. Rybak wrote "The WPCA agreement was needed when the application was for an age-restricted housing zone change. A straight zone change from industrial to residential would not necessarily require the WPCA agreement now. It will be required when the special permit for age restricted housing is submitted under the new rules."

 With no further discussion, M. Szydlo motioned to approve the zone change from Light Industrial to Town Residential (application no. 6373 dated 8/27/18) for the following reasons:
 - The rezoning of the property from Light Industrial (LI-A zone) to Town Residential (TR zone) will permit, subject to special permit and site plan approval by the Zoning Commission, the development of affordable age-restricted housing on the subject property.
 - The zone change and the proposed use of the property is consistent with the 2010 Plan of Conservation and Development and is in keeping with the surrounding residential neighborhood and is the most appropriate use of the land.
 - The Planning Commission gave a favorable report on the proposal.
 - D. Thurston seconded the motion and it passed unanimously.
