Truskauskas **motioned** to continue the hearing to Monday, June 11, 2012 at 7:00 p.m., seconded by R. Lavoie. Motion passed unanimously. LUC Redmond will contact the EDC and the Agricultural Council to ask for input. The public hearing adjourned at 7:07 p.m.

REGULAR MEETING

1. OPEN MEETING - ESTABLISH QUORUM.

Chairman Brazaitis called the meeting to order at 7:07 p.m. Same quorum exists.

2. APPROVE MINUTES OF PREVIOUS MEETINGS: 5/14/12 AND 4/18/12 SPECIAL MEETING (SITE WALK).

A. Buonocore **motioned** to approve the minutes of 5/14/12, seconded by D. Truskauskas. Motion passed unanimously with A. Buonocore, D. Truskauskas and R. Lavoie voting. All others refrained from voting due to their absence at the previous meeting. D. Truskauskas **motioned** to approve the minutes of 4/18/12, seconded by A. Buonocore. Motion passed unanimously with D. Truskauskas, A. Buonocore and P. Brazaitis voting. All others refrained from voting due to their absence at the site walk.

- 5. **EXECUTIVE SESSION WITH ATTY. STEVE BYRNE PENDING LITIGATION, LUCAS V HZC.**D. Truskauskas **motioned** to table item 5 until Atty. Byrne arrives and to table Item 6 until ZEO Nelson arrives. Motion seconded by R. Lavoie and passed unanimously. Atty. Byrne was asked to arrive at 7:30 p.m.

6. COMPLAINTS/ENFORCEMENT ACTIONS.

LUC Redmond informs the commission that two complaints have been called in to the Land Use office regarding ATV use on residential lots. Neighbors are complaining but no written complaints have been received. LUC Redmond informs the commission that even if a written complaint were received, it is her belief that the ATV use does not fall under any Zoning Regulations that could be enforced.

7. ANY OTHER BUSINESS.

There are members of the public who are in attendance who are interested in the status of discussions for a Town Center/Business Zone. They are informed that the commission is still waiting on feedback from the Economic Development Committee and the Planning Commission. They are also informed that there is nothing in writing and that the Zoning Commission just put out a generic inquiry for input. LUC Redmond states that it could be suggested that only the regulations for Home Occupations might be expanded to include other types of businesses.

With the arrival of Atty. Steve Byrne, D. Truskauskas motioned to enter into Executive Session to discuss pending litigation, Lucas v HZC, (Item 5) at 7:32 p.m., seconded by N. LaGanga. Motion passed unanimously. ZEO Karen Nelson is also present. R. Lavoie motioned to exit out of Executive Session at 7:51 p.m., seconded by A. Buonocore. Motion passed unanimously. R. Lavoie motioned to allow Atty. Byrne to request from the court a stay of proceedings for 60 days in the Lucas v HZC matter, seconded by A. Buonocore. Motion passed unanimously.

At this time, ZEO Nelson updates the commission on GRJH. An as built has not yet been completed and the Citation Hearing has been continued to 6/21/12 with Atty. Joel Perlotto as Hearing Officer. Building codes still remain an issue at the GRJH/gas station site. ZEO Nelson informs the commission that the town still holds bonds for TARGA for E&S controls but that only 7 units out of 30 are built at this time. The matter of the Scoville Hill Road chickens has been resolved since the residents at 292 Scoville Hill Road removed them.

ZEO Nelson's May 24, 2012 report has been received by all members of the commission.

10. ADJOURN.

Truskauskas motioned to adjourn the meeting at 8:03 p.m., seconded by N. LaGanga. Motion passed unanimously.
