## **MINUTES OF AUGUST 12, 2021**

#### **GIS MAPPING**

Discussion of bids ensued.

A motion was made by Ms. Arigoni, seconded by Mr. Fredsall to follow the recommendation of the Assessor and hire Flow Analytics to perform the GIS mapping at a price not to exceed \$22,199.60 with the funds coming from the Revaluation Capital Account. All in favor.

## **OLD BUSINESS**

A motion was made by Ms. Arigoni, seconded by Mr. Bobroske to add ARPA funds to the agenda. All in favor.

A motion was made by Mr. Fredsall, seconded by Ms. Arigoni to approve the following projects for ARPA funding, Emergency Management Communication System not to exceed \$ 250,000, SCBA Breathing Apparatuses for HVFD not to exceed \$75,000, 1,000 gallon above ground gas tank with fuel management system not to exceed \$ 81,000 and Town and Library engineering/consulting and design of ventilation systems not to exceed \$35,000. All in favor.

## **NEW BUSINESS**

Memo received from Selectmen concerning purchase of Bentley Dr. property. It is 6.52 acres fronting on Whetstone Rd. and Bentley Dr. for \$ 240,000.

Discussion ensued.

The BOF requests that the Selectmen do perk tests and soil review along with the Town Engineer to determine land use possibilities.

#### **SUPPLEMENTALS**
