### Call to Order

- Valley Road Bridge Mr. Criss shared the progress of the Valley Road Bridge Project. The paperwork is anticipated to be finalized within a couple of weeks.
- Veterans War Memorial Mr. Criss shared that the plinths are starting to be delivered and will be installed once they are all delivered. The project is anticipated to be ready for the Memorial Day Parade.
- Senior Center Mr. Criss shared that the renovations are almost complete.
- **Town Hall Ventilation** Mr. Criss shared that the ventilation project is almost complete.
- ARPA Mr. Criss shared that the after speaking with the Board of Finance to use APRA funds for the fencing around the Conservation Area since it is encouraged to use ARPA funds for usable public space.
- Town Budget Meeting Will take place on Tuesday, May 21<sup>st</sup>, 2024 at 7:00 p.m.
- Region #10 Referendum The referendum will be on May 7<sup>th</sup>, 2024.

- Animal Control Mr. Criss shared that Winsted is interested in sharing ACO services.
- **Transfer Station** Mr. Criss shared that the Northwest Cog is interested in taking over the MIRA facility for the northwest corner to have bulky and hazardous waste and that he is exploring options.
