Board of Trustees Monthly Meeting - November 4, 2013

The meeting was called to order by Co-Chair Leslie Flowers at 7:05 pm.

**Secretary's Report:** Motion to accept last month's minutes as read by Cianciolo, second by Christensen, unanimous.

**Treasurer's Report:** Ahead of last year's annual fund by \$1,875. Overall down in money due to money paid to architect. Bank account balance is off \$16,602 - this money was put in money market account. There is currently \$23,000 in money market account. Motion to accept treasurer's report made by

Christensen, second by Mitchell, unanimous.

Librarian's Report: Auditors were here. Richard, Terry and Lisa S. terms expire and they will have to run in the spring if interested in staying on the Board. We could get an extra point on the grant if the library stays open 45 hours (is currently opened 39.5 hours). Ted Weingart gave money to endowment fund and suggested that we add a statement to the annual fund letter mentioning the endowment fund. Stamps are going up in price in January. Karen will buy an additional 250 now for thank you letters. Ken Best toured the building with John Fredsall. Friends craft sale will be on December 7 and they will accept donated crafts.

## Committees:

Art - Photography of Steven Eazarsky for November & December. There will be candlesticks in the big case.

Budget - Will address in January

Computers - Library has 4 XP computers which won't be supported after the spring. Will keep them going for now.

Fundraising - Car wash - will sell coupons for \$11. No expiration date - only good at the Torrington Platinum Car Wash. Will purchase 250 tickets to be sold in the month of December. Motion to proceed with this made by Kelleher, second by Cianciolo, unanimous. Investments - Board of Advisors wanted input from Fidelity. Fidelity will only talk to authorized account holder. Will try to have the Treasurer attend the next Board of Advisors meeting. Property & Building - Ken Best will be coming to our next Board meeting in December. Leslie invited Peter Thierry via email and will do so again by letter.

Governance - as previously mentioned

Correspondence - Leslie will write thank you notes to Friends for all they do, the Garden Club for their work and to Mr. Weingart for endowment donation.
