# PLANNING COMMISSION MEETING WEDNESDAY, JUNE 25, 2014 TOWN HALL 7:00 P.M.

#### **PUBLIC HEARING - continued**

### 1. OPEN HEARING - ESTABLISH QUORUM.

Chairman Orefice called the meeting to order at 7:00 p.m. All regular members present are seated. Commissioners Souchuns and Emery have both listened to the recordings of the previous public hearings on this application and are qualified to be seated, discuss and vote.

2. PICKETT BROOK PROPERTY, LLC – APPLICATION FOR 2-LOT RESUBDIVISION, 50 WOODCHUCK LANE. Joseph Green, P.E., Robert Green Associates is present with revised plans to 6-24-14. Revisions were made to show the north property line at the corner which is now staked 150-200 feet in an easterly direction along the property line, to add silt fence along the north property line, for the addition of a silt sack on the downhill northern side of the property and for updated contours of the property. On a map provided by Mr. Green, red contour lines represent old contours and new black lines indicate new contours. Sheet 3 has also been revised and is an enlarged copy of Lot 1201-2. The driveway for Lot 1201-2 is also being used as the construction entrance and the plans have been revised to show more detail.

R. Perreault arrives at 7:04 p.m.

Chairman Orefice notes that he had driven by the property before tonight's meeting and did notice that the northern boundary has been staked, Erosion & Sedimentation control measures have been installed and the driveway construction pad is installed.

Chairman Orefice opens the floor to public comment at this time.

Carolyn Kurtich, 62 Woodchuck Lane, questions whether more E&S control measures are required with Chairman Orefice stating that the town's ZEO will keep tabs on erosion control on the site.

Joseph Green points out on the site plan the location of where E&S control measures are installed.

C. Emery motioned to close the public hearing at 7:12 p.m., seconded by P. Roche. Motion passed unanimously.

P. Roche **motioned** to approve the application of Fennwood ReSubdivision, 50 Woodchuck Lane based on the presentation made at public hearings held on 5/28/14, 6/11, 14 and tonight, documentation of approval by TAHD and the site plans compliance with Subdivision Regulations dated 5-20-13. C. Emery seconded the motion and it passed unanimously.
